## **LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT TRUCK PERMITS**

**LOUISIANA REQUIRES THAT A LIABILITY BOND OR CERTIFICATE OF INSURANCE WHICH INSURES ANY DAMAGE TO STATE PROPERTY MUST BE POSTED AT THE TRUCK PERMIT OFFICE BEFORE ANY PERMIT IS ISSUED FOR VEHICLES AND LOADS WHICH ARE OVERWEIGHT OR 14 OR MORE FEET WIDE.**

**IF CHOOSING THE PROPERTY DAMAGE BOND, THE ORIGINAL PROPERTY DAMAGE BOND, POWER OF ATTORNEY FOR THE INSURANCE COMPANY AND THE POWER OF ATTORNEY FOR THE PRINCIPLE MUST BE FURNISHED TO THE TRUCK PERMIT OFFICE.**

**IF CHOOSING A CERTIFICATE OF INSURANCE, THE ACCORD SHOULD SHOW THE LOUISIANA CUSTOMER ACCT #, EFFECTIVE DATE, THE EXPIRATION DATE AS WELL AS THE AMOUNT OF PROPERTY DAMAGE COVERAGE.**

**FOR 1 TRIP (ONLY) THE MINIMUM AMOUNT OF PROPERTY DAMAGE COVERAGE MUST BE \$100,000. IF YOU ACQUIRE MULTIPLE PERMITS, YOU WILL NEED PROPERTY DAMAGE COVERAGE IN THE AMOUNT OF \$250,000.**
