Would like to establish a Surety Bond Account in the amount of \$ _____			

SURETY BOND ACCOUNT

A **Surety Bond** must be posted with the **Truck Permit Office** to establish a **Permit Charge Account**. The bonding insurance agency must execute the bond amount equal to or **exceeding the customers anticipated monthly billing**, with a **minimum of \$1,000.00 or in increments of \$1,000.00**. It is required that the original **Bond, Power of Attorney** for the **Insurance Company** and **Original Power of Attorney** for the **Principal** must be furnished to the **Truck Permit Office**.

General Power of Attorney for Corporations (for Surety Bond): This **Form** is to be filled out if the company is incorporated or a limited liability company. It gives authority to a person to sign the **Bond** as the **Principal** and execute the **Bond** on behalf of the company and must be dated on or before the Bond date.

Customers who fail to pay the full invoice amount of a Charge Account within 15 days (fifteen) days of the billing date will have further charging privileges revoked.

A **Charge Account** allows a customer to purchase books of blank **Permit** forms which may be activated as needed by the permittee, as well as the option of obtaining an **Internet Web Account** (for **Web Permitting** information, please call 225-377-7113). In order to cover printing and handling costs, a fee of **\$5.00** is charged for a book of **50 Permit Forms**.

A Control Permit form (**C-Form**) can be activated by filling it out completely in ink and then placing a telephone call to the **Truck Permit Office** (225-343-2345 – or – 1-800-654-1433). The **Form** is not valid without a **Permit Number**, which is supplied by the **DOTD-Permit Issuing Official** at the time of activation.

The **White** original of the Permit must be carried with vehicle for which it was issued at all times.

WHEREAS, Title 32 of the Louisiana Revised Statutes of 1950, and all rules and regulations adopted thereunder, fixes dimensions weight and load limits, special permit fees and charges for certain vehicles operating upon Louisiana and other specified highways.

NOW, the condition of this bond is such that if the Principal shall promptly pay unto the Department of Transportation and Development of the State of Louisiana all special permit fees and charges due by the Principal as provided for in said Act and rules and regulations adopted in connection therewith for the movement of vehicles of excess weight or dimension over the Highways of the State of Louisiana, then this obligation shall be null and void; otherwise, to be and remain in full force and effect.

It is mutually understood and agreed between all parties hereto, that if the Surety shall so elect, this bond may be cancelled by giving thirty (30) days notice in writing to the Department of Transportation and Development, State of Louisiana, Permit Section, P. O. Box 94042, Baton Rouge, Louisiana 70804-9042. And this bond shall be deemed cancelled at the expiration of thirty (30) days from date of receipt of such notice, the said Surety remaining liable for all special permit fees and charges covered by this bond, which may have accrued up to date of such cancellation, under the terms, conditions, and provisions of this bond.
